Why Gallant University Law School?

The Gallant University Law School is one of the top public law schools in the United States. Our mission is produce socially conscious thinkers and leaders for our nation – graduates who will innovate and lead across all fields- including activism, academia, government, business and of course law.

Approximately 1,200 students are enrolled in the full-time J.D. degree program and about 500 in the School's five LL.M. degree programs. Students learn critical legal theory and doctrine in classes that average a 11:1 student/faculty ratio. Since its founding in 1899, Gallant University Law School has welcomed qualified students without regard to race, gender, or religion and students continue to enjoy a supportive and collegial environment that encourages both individuality and community engagement. Through various programs run by the schools legal clinics (including the Bush Legal Aid Clinic and the Arlington Center for Justice), all Gallant University law students get to represent real clients with real-world legal problems under the guidance of the clinical faculty.

Fees and Payments

The tuition and fees for the Law School are set by Gallant University and are reviewed annually. A student's cost of education is made of up both billed costs (tuition and fees) and indirect costs (living expenses, books, and supplies). Students may receive financial aid up to (but not exceeding) their total cost of education each academic year. Tuition fees vary, depending on many factors, for instance your nationality, your place of residence and whether this is your first or second study program.

Cost of Degree Tuition Policy: For all new entering students, the Cost of Degree Tuition Policy provides a guaranteed tuition rate for each year of the curriculum. Once determined, your tuition cost per year will remain fixed until completion of your degree. Future increases will apply only to those entering in subsequent years. This policy will allow for financial planning upon entry to Law School and will reduce the concerns and uncertainty experienced by students around the yearly setting of tuition costs.

Tuition Payment: Tuition charges are divided into two equal payments, the first in August, and the second in January. Likewise, financial aid disbursements are divided into two equal payments and disbursed at the beginning of each semester. If you withdraw, refund of tuition and fees is subject to the University's refund policy.

Financial Aid: Graduates of the Gallant University School of Law maintain one of the lowest debt levels when compared with graduates from other, similar research-oriented Law schools. Tuition and financial aid policies are designed to enable students to take advantage of opportunities to earn income and explore scholarly interests simultaneously, further reducing their need to borrow. Applicants must be U.S. citizens or permanent residents; federal and institutional need-based financial aid is not available to foreign students.
